How to Enter:

New Members must establish a checking and savings account, sign up for our e-services and apply for a new loan. Existing members must sign up for our e-services and apply for a loan. If you need to sign up for E-Banking, you can visit our website at www.lphwfcu.com. New and Existing members must complete the previous offers by April 12, 2012 in order to be eligible for automatic entry.

To enter without enrolling, hand print the word "Sweepstakes," your name, address, city, state, zip code, daytime and evening phone numbers, date of birth and email address on a "3x5" index card and mail it in an envelope to: Sweepstakes, 433 Metairie Road Ste 114 Metairie, LA 70005. Entries will not be accepted at FDLFCU offices or branches. Entries, other than automatic entries, must be mailed to FDLFCU. Entries must be received by FDLFCU no later than Thursday, April 12, 2012 and become the property of Fleur De Lis Federal Credit Union and will not be returned.

Regardless of the method of entry, you are limited to one (1) entry. By participating in the Sweepstakes, you agree to the terms and conditions of these Official Rules, the eligibility requirements set forth below and to accept the decision of the judges as final in all matters relating to the Sweepstakes.

Eligibility:

The Sweepstakes is open to all members Fleur De Lis FCU who are 18 years of age or older at the time of entry. To enter the Sweepstakes you are not required to purchase goods or services from Fleur De Lis Federal Credit Union. Employees of FDLFCU, their immediate families (parents, children, siblings, spouses) and/or other persons living in the same household as employees, whether related or not, or any other persons/entities directly associated with this Sweepstakes are ineligible to enter or win a prize.

Prize:

One winner will be randomly selected at the end of the promotion. The winner will win one Westinghouse 42" LCD 1080p TV valued at \$399.99. Prizes are non-transferable.

Drawing:

The drawing for the winner of the prize will be held on Friday April 13, 2012. It will be conducted by a judge or judges designated by FDLFCU. The odds of winning are dependent on the number of eligible entries received. You need not be present at the drawing to win.

The winner will be responsible for the payment of any and all applicable federal, state and local taxes imposed on the prize, and may be required as a condition of receiving the prize to provide FDLFCU with his or her Social Security number so that appropriate reports may be filled with the appropriated taxing authorities.

The winner may be required to sign and return an affidavit of eligibility within 14 days of notification attempt. If such an affidavit is required, a failure to return the affidavit in the time noted will result in disqualification of the winner's entry and the random selection of an alternate winner.

Notification:

The winner of the drawing will be notified by phone, mail or e-mail at the number or address listed in FDLFCU's records or on the mail-in entry card within three (3) business days following the drawing. FDLFCU is not responsible for notification that are misdirected or not received because of incorrect or inoperable numbers or addresses. If FDLFCU, after reasonable effort, is unable to contact the winner ten(10) business days from the first notification attempt, that winner will be disqualified and an alternate winner will be randomly selected. Any notification or prize returned as "undeliverable" will result in the disqualification of the winner and the awarding of the prize to an alternate winner.

Consent to Publicity and Release:

Winner agrees that, at FDLFCU's discretion, FDLFCU may publish the name of the winner in its newsletter and on its website, www.lphwfcu.com, and may also request that a photograph of the winner be taken at the time the prize is presented which may be published in the newsletter and on our website.
